KEYNOTE SPEAKER: Regina McMichael, CSP, CET



Not even 21 years old, Regina was suddenly a widow when her husband fell to his death. You've heard from survivors of incidents and even their spouses — but what about a journey of using a workers' comp settlement to pursue a degree in safety and then become an expert in the industy? Regina McMichael has worked as a safety professional for over 25 years, but only recently began to speak publicly about what it means to start your life over and then dedicate it to saving just one life — just one — in trade for the one that was lost. Hear this compelling story and use her insights to keep your career on track and inline with all the conflicting challenges of

being a safety professional. This inspiring program will lift safety professionals to a new perspective on the impact of both the loss of lives and the opportunity to save them. Hear how all the components of safety management must fit together to truly prevent injuries and illness. Translate the passion for what you do into opportunities to truly change your life and those you work with.

OPENING SESSION SPEAKER: Richard Mendelson

Richard Mendelson started his career as a summer intern Clerk at OSHA's Long Island Area Office in 1988. He



moved up through the ranks as a Safety Technician and then a Compliance Officer before being promoted to the New York Regional Office in 1996. At the Regional Office he served in Federal State Operations as a Safety Specialist and the Regional Construction Coordinator. In 2000 he was promoted to Area Director of the Manhattan Area Office, and in 2009 to Deputy Regional Administrator of OSHA Region 2. In January 2016, Richard was selected as Regional Administrator for OSHA Region 3 in Philadelphia, which covers Pennsylvania, Delaware, Mary-

land, Virginia, West Virginia, and the District of Columbia.

CLOSING SESSION SPEAKER: Mark Ames

Mark Ames joined AlHA in November 2016 from ASHRAE (American Society of Heating, Refrigerating and Air-



Conditioning Engineers). At ASHRAE, he co-led their D.C.-based Government Affairs Office, providing strategic direction in the development of their public policy priorities and representing the organization's membership to Congress, the White House, and multiple Federal Agencies. Mark was responsible for the development of policy recommendations in all issue areas at ASHRAE, and provided direction to ASHRAE's State, local, and non-U.S. government affairs activi-

ties. Working with their Board and leaders from 182 Chapters and over 100 technical and other committees, he has played a central role in streamlining ASHRAE's government affairs activities, improving coordination, messaging, and effectiveness, and producing consistent results. Prior to ASHRAE, Mark worked at the National Association of Secondary School Principals (NASSP), and the Native American Contractors Association

(NACA) on a wide variety of diverse issues.

Mark holds a Master's Degree in Applied Politics and a Bachelor's Degree in Political Science from The American University and is a graduate of the university's Public Affairs and Advocacy Institute.

IMPULSE NOISE

This presentation is intended to introduce the audience to the current limitations occupational health and safety professionals face when trying to assign risk to the exposure of impulse noise from weapons fire. In fact OSHA offers little guidance and definitive statements when it comes to impulse noise exposure. NIOSH is currently revisiting their impulse noise exposure guidance. There are many differences between continuous noise and impulse noise including key terminology and damage risk assessment. There is a great debate among impulse noise subject matter experts and until much needed research is performed there may not be a consensus on the horizon. This presentation will introduce the audience to equipment that accurately and not so accurately measures the peak of an impulse waveform.
